Section I — Michael's Own Words and Account (Verbatim)

Did Michael Richard Haimes really kill a dog? Whats the full story?

You might notice my name when searching for me on google so I've included the full story for the first time ever in my life. The crime was so brutal that no one dared approach me afterwards to learn what happened or the aftermath. On September 12, 2012 it had been two months since my mom (deceased, Covid took her, esophageal cancer took my dad) heard that her yoga instructor wanted to put the dog she owned up for adoption and my mom accepted it. It had tremendous anxiety whenever she left so much so that Bodhi (the name of the dog) would bark endlessly whenever my mom left it. The dog was even on a medication for anxiety and I believe it might have been called Ativan or something harder. After two months of being tormented, I was playing a video game and thought that I remembered a trick I was taught on a cruise to Alaska. The trick was that if you down certain bottles of cough medicine then you can do what is called Robo-tripping where you down the whole bottle and feel good for awhile. This was the first time I did it since I was taught about it many years ago on a cruise ship. Robo-tripping is known to impair judgements. For example, you can see in some easy to find photos of me that my head was shaved (I had walked outside and said to myself under the effects of dextromethorphan from the cough syrup that it was too darn hot. So I thought shaving my head by myself with a razor was a good idea. I mainly shaved the middle of my head and still had hair on the outside. Then came the decision, I said "God sent an angel to prevent Abraham from killing his own son. Not this time!" I took out a knife and attempted to kill the dog swiftly but knives don't work the way they do in video games. I went to jail silent before my accusers only saying that I at least felt bad about the incident when asked about it by my public defender. No one ever asked me why I did it and so I never explained. When I was under interrogation I was in an enclosed room when one of the two or three officers that were with me inside said to me "We know you did it." So I thought (see attached official polygraph text from the incident where I proved I didn't have sex with the animal) what would be the best way to throw them off? I know! I said "I had sex with the dog." The interrogation room fell dead silent and all questioning stopped. They didn't even continue to press me for a confession about what I saw at the time as a sacrifice to God that I had attempted. I was charged with animal cruelty (at the time it carried a much lesser sentence then it does today) and having sex with an animal which I didn't even know was a crime at the time. I spent 9 months in jail and 9 months on probation when I think the minimum sentence for the same crime today would have cost me 4 years in prison. I honestly thought it would be over with quickly so seeing the animal suffer at all caused me to go through a phase where I was a vegan for a few years shortly after. I reasoned that I'm personally supporting the killing of other animals whenever I eat meat so I was against that. Now, do I regret it? Absolutely not. The cost of my reputation and one dog dead enables me to impart multiple lessons upon countless others about the dangers of robo-tripping and the dangers of thinking a death caused by a knife must be a fast one because that's all we see in media.

Believing myself to be archangel Michael at the time (it is written no man can see God's face and live yet I saw had seen it after fasting for 3 weeks only on water long before the animal sacrifice to God. I had stated to God "Just kill me already." There was mist seen in a vision before I saw God after thinking those words. He had blue eyes and looked fierce. He said with the tone one used as if someone put a gun to your head and Yahweh said "You want to know the secret things?

Hmmmm?!" and I was frightened and knew my place to answer no due to the tone. And I lived. The other time I saw God's face was in a dream prior to the vision I had while fasting. But this time His eyes were a warm brown and I simply was filled with a deep comfort. If no man can see God's face and live and I saw it twice then I must not count as a man and must instead be an angel. That was my reasoning at the time. But also, when I read the Bible and saw my name in scripture I simply knew upon reading the words about him that "oh, that's me, the Bible is talking about me now."

As far as my education and upbringing goes, I was always the quiet one who would never in a billion years cause true evil to anyone. When moving to a new high school I didn't really gravitate towards making new friends. I went to The University Of South Florida around 2005 where I would graduate with a bachelors of science for political science only after 6 years when it normally only takes people 4 years. I was first a business major until I took one of those classes where the teacher says "look to your left, look to your right, statistically speaking, one of the three of you will fail" and so I failed. Then I switched to be a political science major.

My first book '613 Lies' took me 9 months. I wrote out each one of the 613 mitzvah and the scripture they were supposedly based on and went to actually write out the scriptures they were based upon to see if this addition to the law was justified. The short answer was that it was not.
